CONTACT A POLICYMAKER?

Of course you can! Where do you turn when you want to take action on a local, State or national issue? For much of ASHRAE's history, there wasn't an effective answer to this question. However, responding in 2015, the Society joined the growing ranks of other professional organizations by obtaining user-friendly software that tracks legislation and regulations at the US Federal and State levels.

BillTrack 50/Votility puts everything members need for successful grassroots advocacy contact in one place. This private, member's only platform makes it super simple to engage in policy issues. It enables ASHRAE's members to contact elected and appointed leaders at virtually any level of government to register support for or concern about proposed legislation, regulations, and other policy concerns. Sample letters are provided (which members are encouraged to personalize) and policymakers' email addresses load automatically. All members have to do is fill in their own name, address, email and click SEND. Then, through the wonder of electronic communication, one or dozens of government officials are contacted. The resulting effect is that, for the first time, the grassroots strength and technical expertise of ASHRAE's members can be made known to policymakers at scale - which has the potential to alter the course of legislation and regulations. Because we believe in continuous improvement and, as the saying goes "you can't manage what you don't measure," the software provides us with key metrics that allow us to learn from these efforts, enhancing the effectiveness of future activities.

Although only three Action Alerts have been issued to targeted groups of ASHRAE members, almost 1,000 messages have been sent from members to various government officials on legislation. This is an impressive response for something no one in ASHRAE had used before. **To access the software or to watch a YouTube tutorial, go to www.ashrae.org/GGAC**.

Though the bill tracking portion at this time only follows proposed US Federal and State legislation and regulations, **the element in the software for contacting policymakers can be used anywhere in the world as long as that policymaker has a valid email address**. What a difference software can make and what a difference ASHRAE members can have when united in our efforts for "shaping tomorrow's built environment today!"

Stay tuned: The local Cleveland Chapter GGAC committee will work with ASHRAE Society in understanding how to leverage this platform for contacting local officials on local, state and federal topics.



BUILDING OFFICIALS CONFERENCE OF NORTHEAST OHIO





The Building Officials Conference of Northeast Ohio (BOCONEO) is an organization comprised of building officials, plans examiner, inspectors, fire officials, architects and engineers. Our main purpose is to educate our members in proper code enforcement and develop a better understanding of the various codes and standards. Part of our mission is to reach out to other organizations when we see a potential code change that will affect the work they perform or communicate issues that we come across in the course of our daily duties as code officials.

With the adoption of the 2011 Ohio Mechanical Code, there were changes placed in Section 403, Mechanical Ventilation which updated the outdoor air ventilation requirements so they were consistent with the requirements of ASHRAE 62.1.

Since the time that this change went into effect five years ago, we are still receiving mechanical documents that are not taking into account these requirements. As a plans examiner and moderator for our plans examination roundtable monthly meetings, we have discussed among many plans examiners that only about half the plans that get submitted for review are following the correct method for calculating the outdoor air requirements. In an effort to create better projects and move the plan review process along, BOCONEO wanted to bring this to your organization so that you could discuss this amongst your members and help in the education of those designers who may still be calculating the rates under the old version of the code.


Directions from Cleveland:
